FAMI works to achieve these goals through the activities of its Intellectual Property Rights Sub-Committee (IPRSC), which include introducing measures to prevent the sales of counterfeit products, conducting consumer awareness campaigns, and lobbying governments on this issue.

FAMI IPRSC

From 2024, the name will change from Task Force (TF) to Sub-Committee (SC).

- Concerned with the risks posed by counterfeit motorcycles in Asian markets, FAMI established its IPRSC to proactively support the intellectual property activities of industry groups in individual countries.
- FAMI's IPRSC drafts and promotes action plans aimed at raising awareness regarding intellectual property rights/protection and the conduct of dedicated public relations activities.

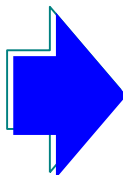

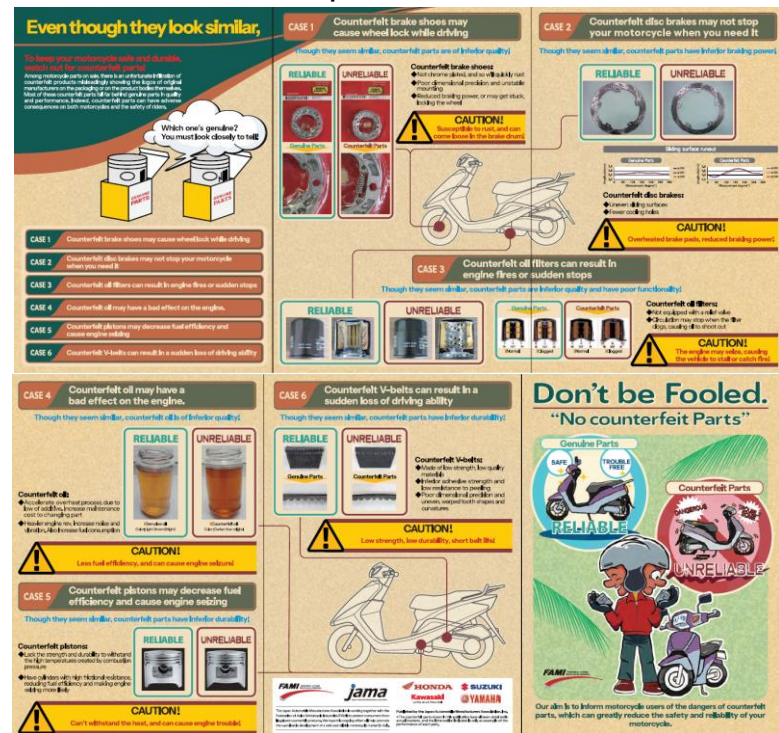
